

RUPEEZY Terms and Conditions for Digital Partner:

- In case a referred client completes his/her account opening within 30 days of being referred.
- An act of being referred would include: the client comes and accept the link shared by the Digital Partner.
- The already registered clients or PAN's in any case are not a part of this scheme.
- Payout Criteria:

1) Minimum 10 active clients,

And either minimum 30% clients (out of total active clients those at least place a single order) should be active Or 5 New accounts opened in the payment month.

Eg:

For October month payout (from 16th Oct to 15th Nov),

Case 1:

Consider your overall active clients numbers = 10

But your monthly (between 16th Oct to 15th Nov) active users = 2

Your brokerage sharing = 15000

Account Opened ((between 16th Oct to 15th Nov) = 2

Then, for such case brokerage sharing of 15000 will be on hold for next eligible payment month as both conditions failed to process the payment 30% active accounts or account opened =5.

Case II:

In the above Case 1:

Consider Accounts opened (between 16th Oct to 15th Nov) =5

Then, in such case, the payout will be released considering accounts opened =5.

Case III:

In the above example of Case 1:

Consider your monthly (between 16th Oct to 15th Nov) active users = 4

and Accounts opened (between 16th Oct to 15th Nov) =2

Then, in such case, the payout will be released considering accounts opened =5.

- All payouts made under this Scheme shall be post Tax Deducted.
- In case the amount is not withdrawn within 365 days from the partner registration date, all such pending amount shall lapse.
- All eligible amounts will be deposited to your saving account (default payout account in your trading account), on or before 21st of every month.
- I/We have read and understood all the terms, conditions, clauses of the NSE and MCX with respect to the "Byelaws" of all the Exchanges, "incentives/referral schemes" rules, and rules with respect to marketing and incentives. I/We understand that by receiving referral incentives from RUPEEZY, I/We and RUPEEZY are both bound by the rules of the Exchanges;

 - I/We acknowledge that details of clients referred to by me/us, such as; contract notes, daily margin statement, statement of accounts, will not be sent to me/us from RUPEEZY without the consent of the referred clients.
 - I/We have not, since being eligible to receive any payment/payout from RUPEEZY, entered into any contracts or published any marketing material/advertisement acting as RUPEEZY or act as a referral agent of RUPEEZY without the explicit written permission of RUPEEZY. I/We understand that publishing any marketing or advertisement material requires permission/intimation towards the Exchanges. I/We will not & have not publish/'ed any marketing material without the explicit permission of RUPEEZY.
 - I/We have/will not post the affiliate link of my referral code on public forums without any context, and spam any such groups/platforms/pages on social media.
 - I/We hereby declare that the above information is true and correct, and if any information is found to be false and incorrect, RUPEEZY will have the right to recover the entire amount received by me/us through whatever means RUPEEZY deems proper.
 - I/We agree to indemnify RUPEEZY and its Directors/employees for any damages/claims that may arise from me/us deviating from the Rules/Bye-Laws of the Exchanges, and any terms, conditions, Policies & Procedures of RUPEEZY.
